Public Works- Nick Brinkman:

* STC- (construction co for Sewer project will not be putting a roof over the UV system as a measure to save costs on project

* The trees in park near the basketball fence and tennis court fence line are getting cleaned up. Nick may utilize a tree service to help with the tree trimming and stump grinding. Not to exceed \$1200.00. Board agrees to this.

* Nick suggested purchasing a new park grill near the large Pavilion and taking down the old one. Will get pricing and add to the upcoming budget.

* Quotes for the Main Pavilion Roof range from \$6 thousand for ridge caps to \$22 thousand for a full tear off. Will discuss more at the March Board Meeting.
