Whereas, the Village Board shall by resolution establish, and from time to time modify local laws.

Moreover, the weed and debris law has been reviewed by the Village Board and WHEREAS, the Village Board held a public hearing on June 12th for the purpose of the ammendment of the Weed and Debris law.

WHEREAS, the occupants of property are now required to remove debris, grass and weeds.

WHEREAS, the provisions must be completed within 5 days of letter.

WHEREAS, the DPW will be able to remove such debris or weeds at the cost of the resident plus a \$250 inspection fee.

NOW THEREFORE BE IT RESOLVED, said local law amendment shall begin at once.
